A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE IMPLEMENTATION OF THE PROJECTS UNDER THE BOTTOM-UP BUDGETING F.Y. 2016

WHEREAS, Section 22 (a) (5) and (c) of the Implementing Rules and Regulations of the Local Government Code states that a Local Government Unit as a corporation shall have the power to enter into contracts provided that it is authorized by the Local Sanggunian;

WHEREAS, in line with the Bottom-Up Budgeting program, a poverty reduction strategy of the Aquino Administration which aims to ensure the inclusion of the funding requirements for local development needs as they are identified at the local level in the budget proposals of participating agencies;

WHEREAS, the Municipality of PURA is one of the beneficiaries of the projects under the Bottom-Up Budgeting program for Fiscal Year 2016 and the Sanggunian Bayan through SB Resolution No. 2014-120 dated Nov. 26, 2014 has approved the list of anti-poverty reduction projects identified in the Local Poverty Reduction Action Plan (LPRAP) of PURA:
