**A RESOLUTION REQUESTING THE PRIVATE INFRA DEVELOPMENT CORPORATION
(PIDC) AND THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO
CAUSE THE ADJUSTMENT OF THE TARLAC-PANGASINAN-LA UNION (TPLEX)
CONCRETE FENCE ALONG SINGAT, PURA, TARLAC**

WHEREAS, sometime year 2013 the construction of the Tarlac-Pangasinan-La Union (TPLEX) was completed;

WHEREAS, part of the TPLEX was constructed adjacent to the Barangay Hall of Singat, Pura, Tarlac;

WHEREAS, a concrete fence surrounding the main expressway was constructed to prevent outsiders from entering therein;

WHEREAS, because of the above mentioned fence, the passage/way from the Gerona-Pura-Guimba road leading to the Barangay Hall of Singat was unintentionally narrowed that no motor vehicle except motorcycles can traverse the said passage;

WHEREAS, the Barangay Council of Singat, Pura went to the legal department of the DPWH for some advice on the matter and they were advised to seek the help of the Sangguniang Bayan of Pura to request that the above mentioned fence affecting the passage be adjusted so as to enable motor vehicles to pass through;

WHEREAS, upon due consultation and inquiry, the Sangguniang Bayan was convinced that there is a necessity to adjust the afore-mentioned fence;

NOW THEREFORE, on motion unanimously seconded by all Sangguniang Bayan Members present, this Body, in an open session duly assembled RESOLVES that by means of this resolution, the Sangguniang Bayan of Pura formally requests from the PIDC and DPWH that the Concrete Fence

affecting the passage leading to the Barangay Hall of Singat, Pura, Tarlac be adjusted to an extent that would enable motor vehicles to pass through.
