RESOLUTION NO. 018

Series of 2016

**A RESOLUTION REALIGNING THE AMOUNT OF TWO MILLION ONE HUNDRED
THIRTEEN THOUSAND FIVE HUNDRED FIFTY ONE PESOS AND 44/100 (P 2,113,551.44)
FROM THE GENERAL FUND OF THE MUNICIPALITY FOR THE IMPLEMENTATION OF
THE FIRST TRANCHE OF THE COMPENSATION ADJUSTMENT OF THE MUNICIPAL
EMPLOYEES, APPOINTIVE OR ELECTIVE**

WHEREAS, the President of the Republic of the Philippines signed Executive Order No. 201, S. 2016 on February 19, 2016, entitled "*Modification of Schedule for Civilian Government Personnel and Authorizing the Grant of Additional Benefits for both Civilian and Military and Uniformed Personnel*".

WHEREAS, the purpose of Executive Order No. 201 is to ensure that the compensation structure of government personnel be comparable with the prevailing rates in the private sector thereby attracting and retaining competent and committed civil servants;

WHEREAS, Section 2 of the Executive Order states that the modified Salary Schedule authorized therein shall apply to all civilian personnel in the Executive, Legislative and Judicial Branches, Constitutional Commissions and other Constitutional Offices, Government-Owned or Controlled Corporations (GOCCs) not covered by Republic Act No. 10149, and Local Government Units (LGUs), regardless of appointment status, whether regular, contractual or casual; appointive or elective; and on full time or part-time basis;

WHEREAS, the Mid-Year Bonus, Enhanced Performance Based Bonus (PBB), and Productivity Enhancement Incentive (PEI) provided therein shall apply to both civilian personnel, and military and uniformed personnel, except for the increase in Hazard Pay which applies only to the MUP. However, individuals whose services are engaged through job orders, contracts of service, consultancy contracts and service contracts with no employer-employee relationship are excluded from the salary increase and benefits authorized therein;

WHEREAS, the Department of Budget and Management issued Local Budget Circular No. 108 dated February 24, 2016 for the Implementation of the First Tranche Compensation Adjustment for Local Government Personnel;

WHEREAS, the members of the Sangguniang Bayan, after careful deliberation, recommends the Implementation of the First Tranche Compensation Adjustment for Local Government Personnel;

NOW THEREFORE, on unanimous motion presented, be it:

RESOLVED, as it hereby resolved, to realign the amount of Two Million One Hundred Thirteen Thousand Five Hundred Fifty One Pesos and 44/100 (P 2,113,551.44) from the General Fund of the Municipality for the Implementation of the First Tranche Compensation Adjustment of the Municipal Employees, Appointive or Elective;

RESOLVED FURTHER, to implement the First Tranche Compensation Adjustment for Local Government Personnel; (A copy of the pertinent Compensation Adjustment Schedule for Local Government Personnel is appended herewith and the same forms part of this Resolution.)

RESOLVED FINALLY, to furnish copies of this resolution all concerned offices/agencies for their information and appropriation action.
