A RESOLUTION DECLARING OPERATIVE THE APPROPRIATION ORDINANCE NO. 02, SERIES OF 2016 OF BARANGAY POBLACION 2 AUTHORIZING SUPPLEMENTAL BUDGET INVOLVING AN AMOUNT OF FORTY SEVEN THOUSAND ONE HUNDRED FIFTY SEVEN PESOS AND 62/100 (P47,157.62) TO BE UTILIZED FOR THE VARIOUS EXPENDITURES OF THE BARANGAY

WHEREAS, the Department of Budget and Management (DBM) issued Budget Circular 2016-3 to prescribe the rules and regulations on the grant of the Mid-Year Bonus to government personnel for FY 2016 pursuant to Executive Order (EO) No. 201, s. 2016, entitled "Modifying the Salary Schedule for Civilian Government Personnel and Authorizing the Grant of Additional Benefits for Both Civilian and Military and Uniformed Personnel", as approved by the President on February 19, 2016;

WHEREAS, pursuant to Paragraph 2.1, the Circular shall apply to all positions for civilian personnel, whether regular, casual, or contractual in nature, appointive or elective, full-time or part-time, now existing or hereafter created in the Executive, Legislative and Judicial Branches, the Constitutional Commissions and other Constitutional Offices, SUCs, and GOCCs covered by the Compensation and Position Classification System (CPCS) under Republic Act (RA) No. 6758, as amended by Senate and House of Representatives Joint Resolutions No. 1, series of 1994, and No. 4, series of 2009, and in LGUs;

WHEREAS, to be able to grant the Mid-Year bonus to the personnel of Barangay POBLACION NO. 2, there is a necessity for the realignment of funds from available sources to approved its Appropriation Ordinance No. 02, Series of 2016;

NOW THEREFORE, on motion of Councilor Teodora D. Robino, duly seconded, it was:

RESOLVED, as it is hereby resolved, to declare Appropriation Ordinance No. 02 of Barangay Poblacion No. 2 involving an amount of **FORTY SEVEN THOUSAND ONE HUNDRED FIFTY SEVEN PESOS AND 62/100 (P47,157.62)**, to be utilized for various expenditures of the barangay including the grant of Mid-Year Bonus to qualified barangay personnel for FY 2016;
