**A RESOLUTION REALIGNING THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS
(P400,000.00) WHICH WAS APPROPRIATED FOR ELECTION EXPENSES TO FINANCE
THE VARIOUS IMPORTANT ITEMS OF EXPENDITURES UNDER THE OFFICE OF THE
MUNICIPAL MAYOR AND OFFICE OF THE HUMAN RESOURCE MANAGEMENT
OFFICER**

WHEREAS, the municipality appropriated the amount of **FOUR HUNDRED THOUSAND PESOS (P400,000.00)** for Election Expenses Under the Special Purpose Appropriation of the 2016 Municipal Annual Budget;

WHEREAS, pursuant to Section 10, Article 1 of the OMNIBUS ELECTION CODE OF THE PHILIPPINES, Except in barangay elections, such expenses as may be necessary and reasonable in connection with the elections, referenda, plebiscites and other similar exercises shall be paid by the Commission;

WHEREAS, the amount stated above is now available to be utilized for the various important items of the municipality expenditures under the Office of the Municipal Mayor and Office of the Human Resource Management Office;

WHEREAS, there is a need to realign the amount of **FOUR HUNDRED THOUSAND PESOS (P400,000.00)** to be utilized for the various important items of expenditures under the Office of the Municipal Mayor and the Office of the HRMO;

NOW THEREFORE, on unanimous motion presented, be it:


RESOLVED as it is hereby RESOLVED realign the amount of **FOUR HUNDRED THOUSAND PESOS (P400,000.00)** which was appropriated for election expenses to finance the various important items of expenditures under the Office of the Municipal Mayor and Office of the HRMO;
