A RESOLUTION RATIFYING THE CONTRACT AGREEMENT ENTERED INTO BY AND BETWEEN THE MUNICIPALITY OF PURA, REPRESENTED BY THE HONORABLE MAYOR CONCEPCION A. ZARATE, M.D., AND AUB CONSULT MANAGEMENT AND ENGINEERING SERVICES, REPRESENTED BY AURELIO U. BATTAD, FOR THE DETAILED ENGINEERING DESIGN WITH MONITORING AND SUPERVISION OF THE CONSTRUCTION OF PURA WATER SUPPLY SYSTEM LEVEL 3

WHEREAS, the Municipality of Pura, planned to extend its Water System to cater the remaining barangays in the municipality, which are not yet being supplied by the existing water system;

WHEREAS, a competitive bidding pursuant to the Government Procurement Reform Act was conducted for the detailed engineering design of the said project and such was awarded to AUB CONSULT MANAGEMENT AND ENGINEERING SERVICES being the winning bidder;

WHEREAS, the Executive Department of the Municipality of Pura, represented by the Honorable Municipal Mayor, entered into a contract agreement with the highest bidder in connection with the above-mentioned project without first consulting and/or obtaining authorization from the Sangguniang Bayan of Pura;

WHEREAS, realizing the aforementioned unintentional error, the Office of the Municipal Mayor furnished the Sangguniang Bayan a copy of the contract and respectfully requested for its ratification;

WHEREAS, after hearing by the proper committee and after presenting it to the Sanggunian for inquiries, the Sangguniang Bayan finds the provisions of the contract to be reasonable and proper and agreed to ratify the same for its implementation;

NOW THEREFORE, on motion by Councilor John Paul M. Balmores, duly seconded, be it.
