A RESOLUTION AUTHORIZING THE PURCHASE OF A ONE THOUSAND ONE HUNDRED SIXTY TWO (1,162) SQUARE METER PORTION OF THAT PARCEL OF LOT IDENTIFIED AS LOT F-1 OF PSD-03-212110 COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 043-2014010297 LOCATED AT BARANGAY SINGAT, PURA, TARLAC, AND FURTHER AUTHORIZING THE LOCAL CHIEF EXECUTIVE OF PURA TO ENTER AND SIGN, IN BEHALF OF THE MUNICIPALITY, INTO A DEED OF ABSOLUTE SALE WITH THE OWNER THEREOF

WHEREAS, the Municipality of Pura plans to extend its existing water system to cater the remaining barangays not yet supplied by the Pura Water System;

WHEREAS, the Municipality was granted financial assistance through the 2016 Bottom-Up Budgeting which will be utilized for the SALINTUBIG Project of the Municipality;

WHEREAS, the proposed water system will be erected at Barangay Singat, Pura, Tarlac where it was found to be the most strategic and convenient site for the said project;

WHEREAS, the Municipality of Pura offered to buy a portion of LOT F-1 of that parcel of lot covered by TCT NO. 043-2014010297 owned by MR. ROBERTO MILLO, and the latter agreed;

NOW THEREFORE, on motion by Councilor John Paul M. Balmores duly seconded, RESOLVED as it is hereby RESOLVED to AUTHORIZE THE PURCHASE OF A ONE THOUSAND ONE HUNDRED SIXTY TWO (1,162) SUARE METER PORTION OF THAT PARCEL OF LOT IDENTIFIED LOT F-1 OF PSD-03-212110 COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 043-2014010297 LOCATED AT BARANGAY SINGAT, PURA, TARLAC,

RESOLVED FINALLY, to furnish copies of this resolution to other government agencies concerned.


