A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A GENERAL MEMORANDUM OF AGREEMENT, IN BEHALF OF THE MUNICIPALITY, WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE 3, IN RELATION TO THE VARIOUS PROGRAMS OF THE DWSO AND AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO SIGN THE SPECIFIC IMPLEMENTING AGREEMENT FOR THE SUPPLEMENTARY FEEDING PROGRAM OF DSWD FIELD OFFICE 3

WHEREAS, the DSWD has the mandate to provide a comprehensive program of social welfare services designed to ameliorate the living conditions of the distressed/ affected Filipino families especially those who are handicapped by reason of poverty;

WHEREAS, to be able to achieve its mandate, the DSWD has the following programs: ASSISTANCE TO INDIVIDUAL IN CRISIS SITUATION, SOCIAL PENSION PROGRAM, SUPPLEMENTARY FEEDING PROGRAM, DAY CARE SERVICE PROGRAM, SUSTAINABLE LIVELIHOOD PROGRAM, DISASTER MANAGEMENT PROGRAM and PANTAWID PAMILYA PILIPINO PROGRAM;

WHEREAS, for the implementation of the said contract, the Municipality needs to enter into a General Memorandum of Agreement and Specific Implementation Agreements with the DSWD;

NOW THEREFORE, on motion by Coun. John Paul M. Balmores, duly seconded, RESOLVED as it is hereby RESOLVED, to AUTHORIZE THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A GENERAL MEMORANDUM OF AGREEMENT, IN BEHALF OF THE MUNICIPALITY, WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE 3, IN RELATION TO THE FOLLOWING PROGRAMS: ASSISTANCE TO INDIVIDUAL IN CRISIS SITUATION; SOCIAL PENSION PROGRAM; SUPPLEMENTARY FEEDING PROGRAM; DAY CARE SERVICE PROGRAM; SUSTAINABLE LIVELIHOOD PROGRAM; DISASTER MANAGEMENT PROGRAM; and PANTAWID PAMILYA PILIPINO PROGRAM OF THE DWSO.

RESOLVED FURTHER, to AUTHORIZE THE LOCAL CHIEF EXECUTIVE TO SIGN THE SPECIFIC IMPLEMENTING AGREEMENT for the SUPPLEMENTARY FEEDING PROGRAM OF DSWD FO 3.
