**A RESOLUTION AUTHORIZING THE REALIGNMENT OF TWO HUNDRED THREE
THOUSAND PESOS (P 203,000.00) FROM AVAILABLE SAVINGS IN THE MOOE OF THE
OFFICE OF THE MUNICIPAL MAYOR TO AUGMENT THE DEPLETED FUNDS OF THE
SAME OFFICE AND TO FINANCE THE ANTI-DRUG CAMPAIGN OF THE MUNICIPALITY**

WHEREAS, the Local Chief Executive requested for the realignment of Two Hundred Three Thousand Pesos (P203,000.00) to augment the depleted funds under the Office of the Municipal Mayor and to finance the Anti-Drug Campaign of the municipality;

WHEREAS, funds are available for realignment from savings in the MOOE of the same office;

WHEREAS, the Local Government Code of 1991 provides that a Supplemental Budget may be enacted by way of budgetary realignment to set aside appropriations for the payment of services which are exceptionally urgent and the sources of funds available for appropriations are clearly indicated and certified under oath by the local treasurer and local accountant attested by the Local Chief Executive.

NOW THEREFORE, on unanimous motion of Councilor Timoteo D. Balmores duly seconded, be it:

RESOLVED, as it is hereby resolved, to authorize the realignment of Two Hundred Three Thousand Pesos (P203,000.00) from available savings in the MOOE under the Office of the Municipal Mayor to augment the depleted funds under the same office and to finance the Anti-Drug Campaign of the municipality.
