(DILG) REGIONAL OFFICE NO. 3 IN CONNECTION WITH THE IMPLEMENTATION OF
THE PERFORMANCE CHALLENGE FUND (PCF)**

WHEREAS, the Municipality of Pura was among the Local Government Units that were awarded the "**2016 Seal of Good Local Governance**", which was a result of an assessment conducted by the DILG on CY 2015;

WHEREAS, under DILG Memorandum Circular No. 2016-153, recipients of the above-mentioned award are eligible to access the 2016 PCF incentive in the amount of **Three Million Pesos (P 3,000,000.00)** (4TH Class Municipalities);

WHEREAS, the above-mentioned Memorandum Circular provided the guidelines for the release of the aforementioned incentive and among the preliminary requirements thereof is a Memorandum of Agreement between the LGU's and the respective DILG Regional Offices;

NOW THEREFORE, on motion by Councilor John Paul M. Balmores, duly seconded, be it:
